President Marty Hess called the regular meeting of the Urbana City Council to order at 6:15 p.m. City staff attending: Mayor Bill Bean, Director of Administration Kerry Brugger, Director of Finance Chris Boettcher, Director of Law Breanne Parcels, and Community Development Director, Doug Crabill.

PRESIDENT CALLED ROLL: Ray Piper, present; Tony Pena, present; Pat Thackery, present; Cledis Scott, present; Dwight Paul, present; Doug Hoffman, present; and Gene Fields, present.

President Hess led those present in the Pledge of Allegiance.

MINUTES of the regular session meeting of February 7, 2017, were presented for approval. Mr. Thackery moved for the approval of minutes and Mr. Pena seconded. Voice vote on approval: all ayes; nays, none. Motion carried without objection.

COMMUNICATIONS:

1. J&J Schlaegel, Inc. - \$1,338,250.98

Mr. Paul moved to authorize the Director of Administration to enter into a contract for the US 36 East Improvements. Mr. Thackery seconded. Mr. Crabill stated that this project will be funded with Transportation Alternatives Program Grant from ODOT, a grant from the Ohio Public Work Commission, local funds, Urbana Township funds through a cooperative agreement, and state funding through ODOT. Mr. Crabill also advised that this project could begin as early as March. Voice vote on approval: all ayes; nays, none. Motion passed 7-0.

2. Medical Mutual - \$1,312,162.00 - Group Health, Life, Vision and Dental Insurances

Mr. Paul moved to authorize the purchase of group heal insurance and related life, vision (VSP), and dental (Delta Dental). Mr. Thackery seconded. Mrs. Boettcher stated that this was the annual renewal, to which was a straight renewal, being that it is the current policy moving forward. 3. Cherokee Run Landfill - \$4,346.44 (Sewer Fund) Mr. Paul moved to increase Purchase Order #23071 for sludge hauling. Mr. Fields seconded. Mrs. Boettcher stated that the sludge to which had metal in it, had to be hauled to the landfill. She also advised that Mr. Hall is continuing the process of the investigation to who leaked the metal into the system.
