

URBANA CITY COUNCIL TUESDAY, MAY 16, 2017 @ 6:00 p.m.

President Marty Hess called the regular meeting of the Urbana City Council to order at 6:00 p.m. City staff attending: Director of Administration Kerry Brugger, Police Chief Matt Lingrell, Wastewater Superintendent Chad Hall, and Community Development Director Doug Crabill.

PRESIDENT CALLED ROLL: Gene Fields, present; Doug Hoffman, present; Dwight Paul, present; Cledis Scott, present; Pat Thackery, present; Tony Pena; and Ray Piper, present.

President Hess led those present in the Pledge of Allegiance.

MINUTES of the regular session meeting of May 2, 2017, in addition to Work Session Minutes of May 23, 2017 were presented for approval. Mr. Paul Moved for the approval of said minutes and Mr. Fields seconded. Mr. Brugger made a comment that a mistake was made at the last meeting with regard to the Clerk's raise. It was read that it would be a 1.5% increase and should have been read as 1.25% increase to remain consistent with Central Staff. MISCELLANEOUS BUSINESS/WORK SESSION

Mr. Fields reminded all when walking their dogs, they must bring "doggie bags" to pick up after their dogs.

Mr. Paul questioned Mr. Bumbalough the number of projects he had going on. Mr. Bumbalough replied 4 to 5 big projects. Mr. Paul stated that the City was "holding its own" but not getting ahead, and that thoughts about the "nuts and bolts" should be serious.

Mr. Thackery spoke about storm sewer on Scioto Street. He received a call stating that the water was not going down the sewer. Mr. Brugger stated that Collin Stein was looking into that already.

Mr. Piper asked how the Dog Park did at the garage sale. It was advised that \$250.00 were made.

Mr. Bumbalough spoke of the street projects on going.

Mr. Crabill touched to the topic of grass mowing. There are a number of properties that have been mowed by the City already.

Mr. Brugger spoke about all of the activity happening in the City. The pool start up is May 27, 2017, as painting is being finished currently. The Columbia Gas projects (2 phases) is underway. He also spoke about mosquito spray and the county applied for a grant with EPA and was awarded the grant. Q3 project is moving forward as well. He spoke of the 1st meeting in July, he asked that Council consider moving it due to the 4th of July. He spoke on the topic of illegal drug usage and how it impacts the safety services of the City.

Mayor Bean said that it was really important that we speak about safety services, preparing ourselves and preparing the community of what is in store. He stated that it was important that this issue is discussed and acted upon.

President Hess spoke of Work Session topics, future finances and Mr. Brugger said that they would probably take up a bulk of the meeting.

Mr. Fields moved to adjourn. Mr. Paul seconded.

Motion carried without objection.
