

URBANA CITY COUNCIL PUBLIC HEARING TUESDAY, AUGUST 1, 2017 @ 6:00 p.m.

President Mary Hess called the Public Hearing to order at 6:00 p.m. Adam Moore began by speaking about the rezoning request of 415 and 413 S. Main St. He stated that this request initially went to the Planning Commission. The Planning Commission first tabled the request and then they denied the same. He then explained that it was now up to Council, whether they wanted to approve or deny. He further stated that the City feels that the property itself is residential in nature, considers it spot zoning, and to make this change as requested, it must benefit the entire neighborhood.

Joe Smith spoke and said that he didn't think that it was spot zoning. He stated that it was BR-1 and Residential is permitted in BR-1. He further said that business is conditional with the question of is it friendly to the residential environment? He spoke of trends, such as online retail, (Amazon) and quaint little retail shops. He adds that the City should embrace the BR-1 and make the BZA more responsible in start pushing for little retail shops to bring people here to Urbana to shop. He stated his desire to go head to head with PetSmart and would to pursue a business with health food for people and dogs, for he felt there could be a potential market. He said there should be a retail hub of unique shops. He also added to not turn a blind eye to BR-1 and the City needs to rethink what is being done in that area.

He feels that it might be a good idea in hopes of saving the citizens of Urbana some money. Mayor Bean said that he was thinking of trying to get in on the Primary. President Hess added that all 6 zoning topics this evening would be a great topic for an upcoming work session.
