Sealed BIDS will be received by City of Urbana for construction of the Water Reclamation Facility Sludge Handling Improvements Project.

The work consists of providing all labor, tools, equipment and materials necessary to construct:

- Demolition/removal of existing equipment including, but not limited to, portions of belt conveyor, belt filter press, belt filter press feed pumps, piping and valves in belt filter press room, submersible WAS pumps (to be replaced with new) and primary sludge pumps (to be replaced with new).
- Demolition of structures as indicated on the Drawings, including, but not limited to, microwave dryer electrical room, area where new doorway is to be installed and all demolition of floor/walls required for installation of new items.
- Installation and startup of Owner-furnished equipment, including new screw press, reaction tank, screw conveyor control panel, and associated items.
- Provision/installation of all other equipment, piping and valves as shown on Drawings and as specified.
- Electrical and I & C work
- Construction of new screw press room
- Provision/installation of new door and concrete slab on north side of existing building
- Provision/installation of two (2) new submersible sludge pumps and two (2) new primary sludge pumps and associated VFDs
- Modifications to Primary Clarifier Scum removal
- All other related work as shown and specified.

Sealed BIDS will be received for the City of Urbana Water Reclamation Facility Sludge Handling Improvements Project at the City of Urbana Town Hall, 205 South Main Street, Urbana, Ohio 43078 until 12:00 noon (local time) on the 25th day of January, 2019 at which time all BIDS will be publicly opened and read aloud.

Bidders shall accompany their BIDS with a Bid Guaranty in an amount equal to one hundred percent (100%) of the maximum amount bid or a Certified Check or Cashier's Check for 10% of the bid for a period of sixty (60) calendar days after the bid date and in accordance with ORC 153.54.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity. All contractors and subcontractors involved with the project will, to the extent practicable,

use Ohio Products, materials, services and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Champaign County, Ohio as determined by the Ohio Department of Industrial Relations.
