**Advertisement for Bids**

Sealed bids will be received at the Office of the City Engineer of the City of Urbana, 205 South Main Street, Urbana, OH 43078, until 10:00 a.m. local time, Tuesday, May 29, 2018, to furnish all labor, materials, and equipment necessary to complete the project known as 2018 Sidewalk, Curb and Gutter Replacement Program, and at said time and place, be publicly opened and read aloud.

Engineer's Estimate for Base Bid: \$165,997.00

The proposals shall be made on the forms provided in the Bidding Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "2018 Sidewalk, Curb and Gutter Replacement Program". The project consists of sidewalk and curb and gutter replacement on public streets scheduled for paving later in 2018. The final quantity of work awarded to the contractor may vary based on work completed privately by property owners in advance of the city's contract performance period. Property owners have until July 31, 2018 to complete their own work by private contract.

Bids shall be submitted in **duplicate**, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid amount, subject to conditions provided in the Instructions to Bidders. The successful bidder will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.

Each prospective bidder shall be a plan holder of record with the City of Urbana Engineer's Office in order to submit a bid for this project.

No bids shall be withdrawn for a period of sixty (60) days after the opening thereof. Project completion date shall be Friday, September 14, 2018.

The contractor and all subcontractors shall pay employees on the project the prevailing wages established by the Ohio Department of Commerce, Bureau of Labor and Worker Safety, including all updates, and shall comply with the provisions of Chapter 4115 of the Ohio Revised Code. The current Prevailing Wage Rate Schedule is included in the bid documents.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid and to accept any Bid which is deemed by the Owner to be most favorable to the Owner.
